FUNDRAISING AND ADVERTISING

Darryl put a crew together after the last meeting for fundraising. Sam will have Darryl email the board with updates since Darryl is not here tonight. Sam will talk to Rusty about changing the registration to include the additional \$100 for sponsors to pay to get a 2X2 ad in the ice. Those that have paid sponsor fees already will be emailed to see if their sponsor wants to pay the additional \$100.

PLANT

Plant turns on October 8. Floor will be cleaned on October 5. Crew of 6 or 7 will be needed to put just the boards down. Ice needs to be ready on October 21 for learn-to-curls. Website needs to be changed with league start times. Sam will talk to Rusty. October 12 is the deadline that the logos need to be printed. Morning of October 11 is the last call for logos to be sent to printer. Sam will talk to Darryl about sending logos to printer.

PORTFOLIOS

Sam will send email to those on the various portfolios to set up rough estimate of budgets. Greg was added to the "Ice" portfolio.

YOUTH SURVEY

Sam will talk to Rusty about sending out the survey. Michelle will add a folder called "Youth" to Google docs with contacts of parents. Set a deadline of September 30 to do survey. Youth registration not online yet. KidzCurl starts November 3.

YOUTH USCA MEMBERSHIP Kids need to paying USCA members before they can compete in any USCA sanctioned event. Fees for Youth Program are \$30 for KidzCurl, \$30 for Juniors, and \$50 for both. These fees do not register them as a USCA member. Discussion on increasing fees by \$20 to pay for membership and the club will pay the extra \$4 for newsletter from USCA. Carla moved to leave registration as is and leave it up to the coaches of the teams going to competition to pay the USCA fees. Dewey second. Addendum by Kalle to add a box on the youth registration form if parents want to pay the extra fee right away. Sam second. All approve.

REIMBURSEMENT

A reimbursement policy needs to be written to reimburse members for expenses such as travel, ice and house costs, etc. For the Regina trip, the club will pay expenses and credit food. Kalle moved to pass motion. Kayla second. All agree.

DAKOTA CURLING SUPPLIES Club would like them to come this season. Agreed that they should come right away in the season to catch the new curlers that would like to buy supplies. Looking at potentially the first full week of leagues (Wednesday, Thursday?). Greg will check which days will work for them and getting brochures for advertising for Dakota Curling Supplies. Sam will check with Mike Wald about reserving upstairs.

LEDGER

Carla would like to pre-printed labels to put on envelopes when the cash in the bucket is counted at night and a ledger for who counted it, how much, etc. Board agreed this is a good idea.
