## **OLD BUSINESS**

- 1. Locker Contracts
  - a. Discuss number of lockers available/caps on offers/grandfather issues. The new locker rooms will have 83 men's lockers, 55 women's lockers. If all the previous locker owners received a new locker there would be 51 men's claimed and 18 women's claimed. One suggested option is to offer these members the opportunity of 10-year contract @ 450\$ and set new locker fee at \$50.
- 2. Scheduling of Learn to Curls
  - a. Determine when ice will be put in.
    - Curt has indicated earliest start date for putting in ice is likely October 1
      and ice takes about 10-14 days. Leagues are scheduled to start Oct. 21.
      It is likely that the learn to curl will have to be the week before league
      start.
    - ii. Does this work with in-ice advertisements? Yes, expected completion of sponsor list is Sept 15.

- 1. Update on SafeSport certifications
  - a. All board members and coaches working with youth need to be certified or recertified for the year.
- 2. Remodel update
  - a. With the remodel coming to an end there are items that need to be completed before the start of the season. August 7 has been selected as the move in date. This includes emptying the rented bins and organizing the space with the current furniture.
