#### **OLD BUSINESS**

- 1. Putting in ice/Scheduling of Learn to Curls
  - a. Ice install is expected to be completed in early October. DI tanks are needed from CA.
  - b. Should we be doing learn to curls? The Learn to Curl is expected in early October. LS suggests registering the event with Dept. Health. The event should be limited to 32 participants (8 per sheet, 4 per end). This number of participants would need 5-9 instructors. The event would follow current club covid guidelines. Submit a plan to BPR for approval.
- 2. Safe Sport Reminder.
- 3. Remodel Update:
  - a. Locker discussion. The club is essentially finished. BPR is onboard with locker adjustment suggestions to accommodate brooms and more curlers per locker.
- 4. Locker Contracts
  - a. Discuss number of lockers available/caps on offers/grandfather issues. The Men's locker room has 81 total lockers with 55 to be grandfathered. The Women's locker room has 51 lockers with 18 to be grandfathered for 10-yr contract. The first name on last year locker sheets gets the choice to participate. 10-yr contract funds go directly to paying for club remodel, optimally. The remaining lockers will be split between first come first serve for 10-yr contracts and year to year lockers (men's 16/16, women's 19/18).
